- Eligibility to run for Board of Director and Committee officer positions
- Eligibility to submit Technical Committee and Marketing Committee contributions

Small Company Principal Membership – \$5,550 US

All the privileges listed above for a Principal Member

Note: The annual revenue threshold for the Small Principal member category is set at \$20 mil-lion USD, which means Small Company Principal Members must have had annual revenues under \$20 million USD in the previous year. They are required to submit a letter from their CEO stating this.

Auditing Membership – \$4,550 US

- Attendance to all annual and general (i.e., Summit and Plenary)
 meetings of the Forum

Auditing members may NOT attend committee meetings (*i.e.*, Technical and Marketing Work-ing Group meetings) of the Forum and are NOT eligible to submit Technical Committee or Marketing Committee contributions or vote on Forum issues, technical reports or marketing reports

Associate Membership - \$1,200 US

- Attendance to all annual, general and committee meetings of the Forum (but not eligible to vote)
- Access to all working documents, contributions, technical reports, tutorials and meeting minutes
- Subscription to all Broadband Forum email mailing lists

Note: Associate Members must be an educational institution or not for profit. Institutions will be approved for membership annually by a majority vote of the Board of Directors.
